E-NEWSLETTER OF MAHESHTALA MUNICIPALITY FOR THE MONTH OF JANUARY, 2017
ACTIVITIES DURING DECEMBER 2016

1. As per provision of Section 84 of the West Bengal Municipal Act, 1993 the Revised Budget Estimate of Maheshtala Municipality for 2016-17 was placed and approved in the meeting of Board of Councilors held on 29/12/2016.

The gist of the Received Budget Estimates is as follows:-

A. Municipal Fund Budget

- Revised proposed income : Rs. 6225.56 lakh
- Revised proposed expenditure: Rs. 6218.06 lakh
- Revised proposed expenditure in development sector: Rs. 1846.05 lakh
- Provision of pro-poor budget: Rs. 577.50 lakh (31.28% of Development Expenditure)

B. Fund received from Government

- Revised proposed receipt: Rs. 13421.84 lakh
- Revised proposed expenditure: Rs. 13421.84 lakh

The details shall be available from the Revised Budget Estimates already uploaded in the Municipal website.

2. Nirmal Bangla (Amar Souchagar) Programme:

During resurvey in all the wards of Maheshtala Municipality it was transpired that at present the status of households having no house latrine facility or having insanitary one pit (dug well) latrine facility 6039 and 13584 respectively. The former leads to open defecation by the said households and the later leads to environmental risks numbering 13584.

We have taken up construction of individual household latrine unit at a cost of Rs. 10,990/- under Swachh Bharat Mission with Rs. 1000/- from the beneficiaries as their contributory share. Already we have completed 1064 no of toilets.

The one pit household beneficiary will be given a fund of Rs 4600/- each to convert the one pit to two pits. We are pledged to declare our city as open defecation free (ODF) city by 31st March 2017.

3. Third assessment of Municipal properties

As per provision of Section 109 of the West Bengal Municipal Act, 1993 assessment of holdings shall have to be taken up at every five year interval. The next annual valuation of holdings has been started in Wards 1, 2, 3, 4, 5, 7, 9, 10 from 23rd December, 2016.

This has already been brought to the notice of all citizens by information board/leaflet.

The inhabitants of the aforesaid Wards may please co-operate with the Field Assistants to take measurement of their holdings. 31/04/2017 is the target date to complete the works in all 35 Wards. The re-assessed annual valuation shall take effect from 01.04.2017.

4. Remarkable activities under NUHM (National Urban Health Mission):

A. A meeting in connection with Routine Immunization, Pulse Polio Programme and Nirmal Bangla Mission held on 22/12/2016. Chairmnan of Maheshtala Municipality has presided over the meeting. The District Magistrate, the Additional District Magistrate (Development), the Sub Divisional Officer (Sadar), the CMOH of South 24 Pgs. and other officials from the District and District Health and Family Welfare Department were present in the meeting. All FTS, HHW and AWW were also present in the meeting.

All the speakers emphasized on 100% coverage of Routine



Immunization. District Magistrate also emphasized Nirmal Bangla Programme. A power point presentation was made by Dr. A. Sengupta, SMO (WHO).

B. On 20th December 2016 all 'X' marked houses under Pulse Polio Programme were visited by the HHW and FTS with an appeal to administer Routine Immunization and bring their child under Pulse Polio Programme.

C. On 21st December Maheshtala Municipality observed the Foundation Day. Fruits and packets of sweets were distributed among the patient of E. S. I. Hospital, Matri Sadan and Netaji Subhas Maternity Home at Akra. Municipal Building was decorated by light.

5. Activities under Deendayal Antyodaya Yojana-National Urban Livelihoods Mission: WBSULM (West Bengal Urban Livelihood Mission):

- One time Revolving fund of Rs. 10000/- has been given to each of the 21 Self Help Groups (SHGs) which are at least three months old and running group activities properly. 3 new SHGs were formed in this month and group account opened in the respective bank branches.

- Two SHG participated in the Sabala Mela at Budge Budge Subhas Uddan during 17-22 December 2016 organised by the Self Help Group and Self Employment Department, Government of West Bengal.
